Selected Topics

Diversity and inclusion: My work in this area has focused especially on the implicit attitudes model, especially as a means for fostering diversity and enacting substantive changes in institutions, groups, and individuals. Workshops and consultation on these topics have been presented to college and university personnel, therapists, student and community groups, and organizations.

Class, classism, internalized classism: My writing and consulting in this domain have examined considerations of the role of socioeconomic status in personal and interpersonal experiences as well as the role of class as a dimension of institutional and cultural attitudes. This topic is relevant in a range of venues including clinical work, student personnel services, human relations and human resources, group dynamics, and others.

Organization development and group dynamics: My graduate school training in organizational theory and planned organization change, coupled with extensive work as a psychologist and researcher, has provided me with insights and skills to facilitate effective group processes and organization development. I have consulted on team building, volunteer recruitment and training, and candidate assessment, and my experience with the Strong Interest Inventory provides added background for examining career trajectories. I have also consulted on developing and interpreting needs assessments and on program development. I have provided consultation on these matters in venues ranging from a small hospital nursing staff through a city police department to a volunteer recruitment program for a national non-profit.

Contextual issues in psychotherapy: My work in this domain has focused on the impacts of context on clients' experiences. This includes such issues as the value of bringing current events into the therapy room, the need to recognize and work productively with matters of gender, race/ethnicity, class, sexual orientation and gender identity, ability status, religion and faith, and other dimensions of identity (commonly referred to as multicultural psychotherapy), skill at working with internalized oppression, and sensitivity to the profound impact of cultural, institutional, and sociohistorical influences on individual experience.

LGBT issues: My extensive academic and political background in LGBT issues has prepared me well to offer both valuable research-based information and thoughtful applications of this knowledge base across a range of settings where LGBT issues may arise. My own research in this area has also provided me with useful take-home messages that serve to guide practical action. My particular areas of focus in this field have been on the psychological impacts of anti-LGBT actions (ranging from subtle expressions of bias through anti-LGBT politics to hate crimes), the central salience of context (geographical historical, cultural, religious, etc.) in shaping the experience of LGBT people, and LGBT youth (especially topics related to dimensions stretching from depression and suicide to resilience and empowerment).
